STRAIGHT TALK PROGRAM INFORMATION

Scheduling: You are required to call Beckie Hoppe, RN at (810) 257-9462 and schedule your appointment **within one week** of receiving your packet of information.

Program Schedule: Classes are held bi-monthly on Wednesdays.

Program Fee: This program is a community service and there is no cost to you or your family.

Program Time: 9:30am – 3:30pm (late arrivals will not be permitted into the program).

Registration: 9:00am. Please check in at the information desk which is located in the main lobby for directions to register for the Straight Talk Program.

Parking: Please use the visitor parking ramp. This structure is located next to Hurley Medical Center. Parking fee validation will be given after completion of the Straight Talk program.

Valet Parking: Valet parking is available at the main entrance. Valet parking fee will not be covered by the Straight Talk program.

Hospital Amenities: Participants are responsible for paying for their own lunch. A full service cafeteria, vending machines and ATM machines are available.

Program Certificate: Upon completion of the program you will receive a certificate of completion. It **is your responsibility** to return your certificate to the appropriate referring agency within one week.

STRAIGHT TALK PROGRAM RULES

1. **One custodial parent OR Legal Guardian MUST ATTEND with the child for the entire program. Program allows two participants, the referred child plus one custodial parent or legal guardian.**
2. **No tobacco products, lighters, matches, pagers, cell phones, CD players, reading material or weapons of any kind will be allowed.**
3. **No eating or drinking will be allowed in the Auditorium.**
4. **Hurley Medical Center will not be responsible for any lost or damaged property.**
5. **Minors must be accompanied by parent/legal guardian at all times during the program.**
6. **Please be respectful of the program time schedule. Late arrivals will not be permitted to enter once program is in session.**
7. **THIS PROGRAM WILL NOT BE RESCHEDULED. Cancellations and/or failure to attend the entire program are considered a violation of the terms of the program. No certificate will be awarded.**
8. **Participants are to wear appropriate clothing. The following CANNOT be worn during the program:**
 - Hats
 - Tank tops
 - Halter tops
 - Sandals or open toe shoes
 - Mini skirts
 - Shorts
 - Torn clothing (even if purchased torn)
